**THIS TERMINATION OF SECURITY INTEREST** dated as of November 30, 2021 (this "Termination") is made by **U.S. BANK NATIONAL ASSOCIATION**, as Administrative Agent (in such capacity, the "Agent"), under that certain Grant of Trademark Security Interest, dated as of December 11, 2015 (as amended, restated or otherwise modified from time to time, the "Grant") in favor of **AGSPRING LOGISTICS, LLC**, a Delaware limited liability company (the "Grantor"). Capitalized terms used herein and not defined herein shall have the meanings assigned to such terms in the Grant.

**WHEREAS**, pursuant to the Grant, the Grantor granted a security interest to the Agent in all of the Grantor's present and future right, title, and interest in the trademarks, trademark registrations, trademark applications and trademark licenses set forth on Exhibit A attached hereto (the "Trademark Collateral");

**WHEREAS**, the Grantor has requested, and the Agent has agreed, to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, termination, and discharge of its security interest in the Trademark Collateral (the "Released Collateral").

**NOW, THEREFORE**, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Agent hereby releases, terminates and discharges, without any representation, recourse or undertaking of any kind, any and all of its right, title and interest in and to any and all liens on and security interests in the Released Collateral.

The Agent consents and agrees to execute and deliver, at the request and cost of the Grantor, such further instruments, documents and release forms as the Grantor may reasonably request to more effectively release, terminate and discharge any such liens and security interests upon such Released Collateral.

This Termination and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.


