**RELEASE AND TERMINATION  
OF TRADEMARK SECURITY AGREEMENT**

THIS RELEASE AND TERMINATION OF TRADEMARK SECURITY AGREEMENT, dated as of December 1, 2021 (this “Release”), is made by ABC FUNDING, LLC, a Delaware limited liability company, as agent acting for the benefit of Lender Group (in such capacity, the “Agent”), in favor of ROLLAND ENTERPRISES INC. (the “Grantor”). All terms used but not defined herein shall have the meanings set forth (including by reference) in the Security Agreement or Trademark Security Agreement (as defined below).

WHEREAS, the Grantor and the Agent are parties to that certain (i) Guaranty and Security Agreement, dated as of March 6, 2015 (as may be amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), (ii) Trademark Security Agreement, dated as of March 6, 2015 (as amended, restated, amended and restated, supplemented or otherwise modified and in effect from time to time, the “2015 Trademark Security Agreement”) and (iii) Trademark Security Agreement, dated as of August 16, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified and in effect from time to time, the “2018 Trademark Security Agreement”, and together with the 2015 Trademark Security, the “Trademark Security Agreements”), pursuant to which the Grantor granted to the Agent, for the benefit of Lender Group, a continuing security interest in, the Trademark Collateral (as defined in the Trademark Security Agreements), including the Trademarks and the applications and registrations listed on Schedule A hereto;

WHEREAS, the 2015 Trademark Security Agreement was recorded in the records of the United States Patent and Trademark Office on March 9, 2015 at reel 5474, frame 0175;

WHEREAS, the 2018 Trademark Security Agreement was recorded in the records of the United States Patent and Trademark Office on August 16, 2018 at reel 6416, frame 0483; and

WHEREAS, the Grantor has requested and the Agent has agreed to (a) release any and all security interests it may have in the Trademark Collateral and (b) provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, termination, relinquishment and discharge of its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the Trademark Security Agreements, (b) terminate the liens and security interest in the Trademark Collateral, (c) cancel, release and relinquish and discharge its liens on and security interest in the Trademark Collateral, and (d) re-assign, re-transfer and re-convey to the Grantor any and all rights, title and interest it may have in, to or under the Trademark Collateral. The Agent agrees, or authorizes the Grantor, to make filings with the United States Patent and Trademark Office and take further actions, as reasonably requested by the Grantor to evidence the release and termination of the Agent’s security interests in the Trademark Collateral.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK.


