TERMINATION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This TERMINATION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this “**Termination**”) is made, as of December 1, 2021, by JPMORGAN CHASE BANK, N.A., as collateral agent (the “**Collateral Agent**”) in favor of LATIN LOGISTICS, LLC, a Florida limited liability company (“**Latin Logistics**”), AVIANCA HOLDINGS S.A., a *sociedad anonima* duly organized and validly existing under the laws of the Republic of Panama (“**Avianca Holdings**”), AEROVÍAS DEL CONTINENTE AMERICANO S.A. AVIANCA, a corporation organized under the laws of the Republic of Colombia (“**Aerovias**”), INTERNATIONAL TRADE MARKS AGENCY INC., a corporation incorporated and existing under the laws of the Republic of Panama (“**International Trade Marks**”), TAMPA CARGO S.A.S (“**Tampa Cargo**”) and TACA INTERNATIONAL AIRLINES, S.A., a *sociedad anonima* duly organized and validly existing under the laws of the Republic of El Salvador (“**Taca International**,” and together with Latin Logistics, Avianca Holdings, Aerovias, and International Trade Marks, the “**Grantors**”).

RECITALS

WHEREAS, the Grantors and the Collateral Agent are parties to that certain U.S. Intellectual Property Security Agreement, dated as of October 13, 2020 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the “**IP Security Agreement**”);

WHEREAS, pursuant to the IP Security Agreement, each Grantor granted to the Collateral Agent a security interest in all of such Grantor’s right, title and interest in and to the worldwide registered trademarks and trademarks for which worldwide applications are pending set forth in **Schedule A** hereto (collectively, the “**Release Collateral**”);

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of October 13, 2020, among the Grantors and the Collateral Agent (the “**Short Form Security Agreement**”), Grantors, by reference to the IP Security Agreement, reaffirmed their intent to grant the security interest to the Collateral Agent specifically in the Release Collateral;

WHEREAS, the Short Form Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on October 28, 2020 at Reel 7089 and Frame 0541;

WHEREAS, the Collateral Agent wishes to terminate and release all security interests, pledges, assignments, mortgages and liens of record granted to it in the Release Collateral under the IP Security Agreement.

NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent hereby releases, relinquishes and discharges, with respect to each Grantor, all of its lien on and security interest in and to all of such Grantor’s right, title, and interest in, to and under the Release Collateral.

The Collateral Agent hereby authorizes the Grantors, or the Grantors’ authorized representatives to record this Termination with the United States Patent and Trademark Office.

The Collateral Agent authorizes and requests that the applicable intellectual property office record this Termination.

The terms of Sections 11.05 (Governing Law; Jurisdiction; Consent to Service of Process; Immunity), 11.12 (Execution in Counterparts; Integration; Effectiveness) and 11.15 (Waiver of Jury Trial) of the DIP Credit Agreement are incorporated herein as though set forth in full.

This Termination may be signed in counterparts (which may include counterparts delivered by any standard form of telecommunication or electronic mail), each of which shall be an original and all of which together shall constitute one and the same instrument. This Termination shall be governed by, and construed in accordance with, the internal laws of the State of New York and the applicable laws of the United States of America.
