**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this “Release”) is made as of December 2, 2021 (the “Effective Date”), by WELLS FARGO BANK, NATIONAL ASSOCIATION, in its capacity as collateral agent (in such capacity, “Notes Collateral Agent”), in favor of each of Flexential Corp., Flexential Colorado LLC (f/k/a Flexential Colorado Corp.), Flexential Inetu Corp., and Applied Trust Engineering, Inc. (collectively, the “Grantors”).

WHEREAS, reference is made to that certain Indenture dated as of February 5, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Indenture”) among Flexential Corp. (as successor by merger to Flexential Intermediate Corporation), the Guarantors party thereto, and Wells Fargo Bank, National Association, as collateral agent and trustee;

WHEREAS, in connection with the Indenture, Grantors and Notes Collateral Agent entered into that First Lien Notes Pledge and Security Agreement dated as of February 5, 2020 by and among Flexential Topco Corporation, a Delaware corporation, Flexential Corp. (as successor by merger to Flexential Intermediate Corporation), a Delaware corporation, the other Grantors from time to time party thereto and Notes Collateral Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “First Lien Notes Pledge and Security Agreement”);

WHEREAS, pursuant to the First Lien Notes Pledge and Security Agreement, the Grantors granted to Notes Collateral Agent Liens in certain Collateral, including the trademarks listed on Schedule 1 attached hereto (the “Trademark Collateral”) pursuant to that certain First Lien Notes Trademark Security Agreement dated as of February 5, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, “First Lien Notes Trademark Security Agreement”) by and among the Grantors thereto in favor of the Notes Collateral Agent, which was recorded with the United States Patent and Trademark Office at reel 6857, frame 0842;

WHEREAS, the Notes Collateral Agent has consented to the termination, discharge and release of all of its Liens in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Notes Collateral Agent hereby covenants and agrees as follows:

1. All capitalized terms used, but not otherwise defined herein, shall have the meanings set forth in the Indenture or the First Lien Notes Trademark Security Agreement.
2. Notes Collateral Agent hereby terminates, discharges and releases all Liens in the Trademark Collateral..
3. To the extent Notes Collateral Agent acquired any other interest in the Trademark Collateral, Agent hereby assigns, transfers and conveys to each applicable Grantor, all of Notes Collateral Agent’s right, title and interest that it may have, whether by assignment or otherwise, in and to the Trademark Collateral.
4. Notes Collateral Agent hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release at the Grantors’ sole cost and expense.
