**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

WHEREAS, Lender recorded the IP Security Agreement on October 2, 2019 at Reel 6762, Frame 0246 with the United States Patent and Trademark Office; and

WHEREAS, Grantor has requested that Lender release its security interests in the Trademarks listed on Schedule I hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby fully discharges, releases and terminates its security interests in and liens on the Trademarks listed on Schedule I hereto and any right, title or interest of the Lender in the foregoing under the Security Documents shall hereby cease and become void.
