TERMINATION AND RELEASE OF  
TRADEMARK SECURITY AGREEMENTS

This TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENTS (“Termination and Release”) dated as of December 1, 2021, is made by MONROE CAPITAL MANAGEMENT ADVISORS, LLC, as administrative agent for the Lenders (the “Administrative Agent”) in favor of the Grantors listed on Schedule A hereto (the “Grantors”). Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Credit Agreement (as defined below) or the applicable Trademark Security Agreement (as defined below), as applicable.

WITNESSETH:

WHEREAS, pursuant to that certain Credit Agreement dated as of March 30, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), the applicable Grantors executed (i) a Trademark Security Agreement dated as of March 30, 2018, recorded with the United States Patent and Trademark Office on April 2, 2018 at Reel 6310, Frame 0718, (ii) a Trademark Security Agreement dated as of October 9, 2018, recorded with the United States Patent and Trademark Office on October 9, 2018 at Reel 6452, Frame 0653, (iii) a Trademark Security Agreement dated as of December 1, 2020, recorded with the United States Patent and Trademark Office on December 1, 2020 at Reel 7119, Frame 0130, and (iv) a Trademark Security Agreement dated as of March 19, 2021, recorded with the United States Patent and Trademark Office on March 22, 2021 at Reel 7238, Frame 0397, (each, a “Trademark Security Agreement” and collectively, the “Trademark Security Agreements”), pursuant to which such Grantors granted a continuing security interest to the Administrative Agent, for the benefit of the Lenders, in the applicable Trademark Collateral, including certain trademarks and/or trademark applications listed on Schedule A hereto and made a part hereof.

WHEREAS, the Administrative Agent now desires to terminate each Trademark Security Agreement and terminate and release its security interest in the applicable Trademark Collateral and reassign any and all rights, title, and interest in the same to the applicable Grantors.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Administrative Agent, for itself and for the benefit of the Secured Parties, hereby irrevocably terminates each Trademark Security Agreement and irrevocably discharges, terminates and releases its Lien on and security interest in all of the applicable Grantors’ right, title and interest in and to the applicable Trademark Collateral, including those trademarks set forth on Schedule A.

2. Administrative Agent hereby assigns, grants and conveys to the applicable Grantors, without any representation, warranty, recourse or undertaking by the Administrative

Agent, any and all of Administrative Agent's right, title, and interest in and to the applicable Trademark Collateral, including those trademark registrations and trademark applications set forth on Schedule A.

3. The Administrative Agent authorizes and requests that the Commissioner of the United States Patent and Trademark Office and any other applicable government authority record this Termination and Release.

4. This Termination and Release and the rights and obligations of the parties hereto shall be governed by and construed and interpreted in accordance with the laws of the State of Illinois and shall be binding upon the parties' representatives, successors, assigns and transferees.
