TRADE MARK ASSIGNMENT

THIS ASSIGNMENT is effective on 1 December 2020

PARTIES

BACKGROUND

1. DEFINITIONS

In consideration of the sum of £1 (ONE POUND) (receipt of which the Assignor expressly acknowledges), the Assignor hereby assigns to the Assignee absolutely with full title guarantee all its right, title and interest in and to the Trade Mark, including all statutory and common law rights attaching to the Trade Mark, together with the goodwill of the business relating to the goods and/or services in respect of which the Trade Mark are registered and/or used; and the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action (including passing off) arising from the ownership of any of the Trade Mark whether occurring before, on or after the date of this Assignment.

3. FURTHER ASSURANCE

Any time after the date of this Assignment, at the request of the Assignee, the Assignor shall and shall use reasonable endeavours to procure that any necessary third party shall, at the cost of the Assignee execute such documents and do such acts and things as the Assignee may reasonably require for the purpose of giving to the Assignee the full benefit of all the provisions of this Assignment.

4. INVALIDITY

4.1 If any provision in this Assignment shall be held to be illegal, invalid or unenforceable, in whole or in part, such provision or part shall to that extent be deemed not to form part of this Assignment but the legality, validity or enforceability of the remainder of this Assignment shall not be affected.

4.2 If any illegal, invalid or unenforceable provision would be legal, valid and enforceable if some part of it were deleted or modified, the provision shall apply with whatever deletion or modification is necessary to give effect to the commercial intention of the parties.

COUNTERPARTS

This Assignment may be executed in any number of counterparts, each of which when executed and delivered shall constitute an original of this Assignment, but all the counterparts shall together constitute the same agreement.

THIRD PARTY RIGHTS

No person other than a party to this Assignment shall have any rights to enforce any term of this Assignment.




