DECLARATION ON BEHALF OF THE OWNER



- (3) Maharishi Foundation, Ltd. is and always has been a Jersey corporation.



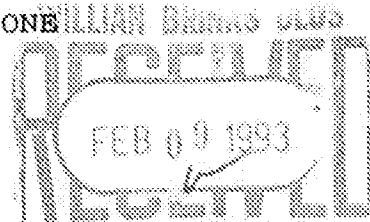

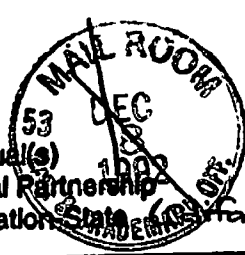
