FIRST LIEN TRADEMARK SECURITY AGREEMENT dated as of December 3, 2021 (this “Agreement”), among CNET MEDIA, INC. (the “Grantor”) and BANK OF AMERICA, N.A., as Collateral Agent (in such capacity and together with successors in such capacity, the “Collateral Agent”).

Reference is made to (a) the First Lien Credit Agreement dated as of November 8, 2017 (as amended by Amendment No. 1, dated as of November 9, 2018, as further amended by Amendment No. 2, dated as of April 15, 2019, as further amended by Amendment No. 3, dated as of June 11, 2019, as further amended by Amendment No. 4, dated as of July 10, 2019, as further amended by Amendment No. 5, dated as of January 27, 2020, as further amended by Amendment No. 6, dated as of October 30, 2020, as further amended by Amendment No. 7, dated as of December 3, 2021 and as it may be further amended, supplemented or otherwise modified from time to time, the “Credit Agreement”), among Ruby Sub, LLC (formerly known as Red Ventures Holdco, LP), a North Carolina limited liability company (“Holdings”), Red Ventures, LLC, a North Carolina limited liability company (“Parent Borrower”), New Imagitas, Inc., a North Carolina corporation (“Co-Borrower”), any Foreign Revolving Borrowers, the Lenders party thereto and Bank of America, N.A., as Administrative Agent, Collateral Agent and Issuing Bank and (b) the First Lien Collateral Agreement dated as of November 8, 2017 (as amended by Supplement No. 1 thereto, dated as of July 26, 2019, as further amended by Supplement No. 2 thereto, dated as of December 20, 2019, as further amended by Supplement No. 3 thereto, dated as of December 3, 2021 and as amended, amended and restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”), among Holdings, Parent Borrower, the Co-Borrower, the other grantors from time to time party thereto and the Collateral Agent. The Lenders and the Issuing Banks have agreed to extend credit to the Borrowers subject to the terms and conditions set forth in the Credit Agreement. The Grantor is an Affiliate of the Borrowers, will derive substantial benefits from the extension of credit to the Borrowers pursuant to the Credit Agreement and is willing to execute and deliver this Agreement in order to induce the Lenders to make additional Loans and the Issuing Banks to issue additional Letters of Credit and as consideration for Loans previously made and Letters of Credit previously issued. Accordingly, the parties hereto agree as follows:

SECTION 1. Terms. Capitalized terms used in this Agreement and not otherwise defined herein have the meanings specified in the Collateral Agreement or the Credit Agreement, as applicable. The rules of construction specified in Section 1.01(b) of the Collateral Agreement also apply to this Agreement.

SECTION 2. Grant of Security Interest. As security for the payment or performance, as the case may be, in full of all Secured Obligations, the Grantor hereby grants to the Collateral Agent, its successors and assigns, for the benefit of the Secured Parties, a security interest (the “Security Interest”) in all of the Grantor’s right, title and interest in, to and under the Trademarks, including the registrations and applications thereof listed on Schedule I (the “Trademark Collateral”).

SECTION 3. Collateral Agreement. The Security Interest granted to the Collateral Agent herein is granted in furtherance, and not in limitation, of the security interests granted to the Collateral Agent pursuant to the Collateral Agreement. The Grantor hereby acknowledges and affirms that the rights and remedies of the Collateral Agent with respect to the Trademark Collateral are more fully set forth in the Collateral Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the Collateral Agreement, the terms of the Collateral Agreement shall govern.

SECTION 4. Counterparts. This Agreement may be executed in counterparts (and by different parties hereto on different counterparts), each of which shall constitute an original but all of which when taken together shall constitute a single contract. Delivery of an executed signature page to this

Agreement by facsimile or other electronic transmission shall be effective as delivery of a manually signed counterpart of this Agreement.

SECTION 5. GOVERNING LAW. THIS AGREEMENT SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK.
