**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this "Release"), dated as of December 1, 2021, is made by JPMorgan Chase Bank, N.A., in its capacity as administrative agent (the "Administrative Agent"), in favor of CDW LLC, an Illinois limited liability company (the "Grantor"), as follows:

WITNESSETH:

WHEREAS, pursuant to that certain Guarantee and Collateral Agreement, dated as of June 24, 2011 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time to date, the "Security Agreement"), among the Grantor, CDW Corporation, the Subsidiaries of Grantor party thereto and the Administrative Agent, and those certain agreements described on Annex I attached hereto (the "IP Security Agreements" and each, an "IP Security Agreement"), the Grantor granted a security interest in certain collateral in favor of the Administrative Agent, including the IP Collateral (as hereinafter defined); and

WHEREAS, the Administrative Agent now desires to terminate and release each IP Security Agreement and the entirety of its security interest in the IP Collateral described on Annex II attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Administrative Agent hereby agrees as follows:

1. Terms. Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Security Agreement.

2. Definitions. The term "IP Collateral", as used herein, shall mean all of the Grantor's right, title or interest in, or to any and all of the trademarks, patents and copyrights listed on Annex II attached hereto. Capitalized terms not defined herein have the meanings set forth in the Security Agreement or the applicable IP Security Agreement, as applicable.

3. Release of Security Interest. The Administrative Agent, without recourse, representation or warranty and at the Grantor's sole cost and expense, hereby terminates, cancels, releases, relinquishes and discharges, in its entirety, for the benefit of the Grantor, and its successors and assigns, its security interest in and to the IP Collateral, the IP Security Agreements and any and all right, title and interest of the Administrative Agent in, to and under the IP Collateral shall hereby be terminated, cancelled, released, relinquished and discharged. The Administrative Agent hereby authorizes the Grantor and its successors, assigns or other legal representatives to file this Release with the Trademark Division of the United States Patent and Trademark Office, the Patent Division of the United States Patent and Trademark Office and the United States Copyright Office, at the sole expense of the Grantor, to evidence and effectuate the release and termination of the Administrative Agent's security interest in the IP Collateral.


