TRADEMARK ASSIGNMENT

or applications or in conjunction with which the Trademarks are used, together with the goodwill of the business associated with and symbolized by the Trademarks and the right of the Assignee to bring actions and claim relief in respect of any infringement or other violation of rights with respect to any of the Trademarks occurring prior to the date hereof TO HOLD the same unto the Assignee absolutely.

The Assignor hereby consents, without any objection, that Assignee solely request recording of this transfer in any jurisdiction where a recording of this transfer may be affected. Assignor agrees that it will cooperate fully with Assignee in completing any further documents which shall be reasonably requested by Assignee in order to complete the assignment of right, title and interest to the Trademarks.
