GRANT OF SECURITY INTEREST
IN TRADEMARKS

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, WORK 'N GEAR, LLC, a New York limited liability company (the "Grantor"), hereby grants to EASTERN BANK, a Massachusetts bank (the "Grantee"), a continuing security interest in (i) all of Grantor's right, title and interest in, to and under the trademarks owned by it, including without limitation those trademarks set forth on Schedule A attached hereto (the foregoing, collectively the "Marks"), (ii) all proceeds and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same. Notwithstanding the foregoing, the Marks shall exclude any trademarks consisting of intent-to-use trademark applications for as long as, and to the extent that, granting an assignment therein may affect or impair the validity or enforceability of any such intent-to-use trademark applications or any registration issuing from such intent-to-use trademark applications.


