TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "*Termination and Release*") is granted as of December 20, 2021 by **SECOND AVENUE CAPITAL PARTNERS LLC**, in its capacity as administrative agent and co-collateral agent for its own benefit and the benefit of the other Lenders (in such capacity, the "*Agent*"), in favor of **MAROLINA OUTDOOR INC.**, a Delaware corporation, and **FISHWORKS, INC.**, a California corporation (collectively, the "*Grantors*").

WHEREAS, the Grantors executed and delivered an Intellectual Property Security Agreement dated as of August 1, 2019 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "*Grant*"; all capitalized terms used but not defined herein shall have the meaning set forth in the Grant), granting the Agent a security interest in and lien on certain trademarks and trademark applications ("*Marks*") described therein, which was recorded with the United States Patent and Trademark Office ("*USPTO*") on August 2, 2019, at Reel 006710, Frame 0883;

WHEREAS, the Grantors have requested that the Agent hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantors in, to and under all of the Marks and Trademark Licenses as herein provided; and

WHEREAS, the Grantors have requested that the Agent provide a document suitable for recording with the USPTO to evidence the release of the Agent's security interests in and liens on the Marks and Trademark Licenses as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby:

1. terminates the Grant and releases, terminates and discharges all liens and security interests in the Grantors' right, title and interest in, to and under (i) the Trademark Licenses and Marks, including without limitation those trademarks, trademark licenses and trademark applications identified in Schedule A hereto, (ii) all proceeds and products of the Marks and Trademark Licenses, (iii) all goodwill associated therewith, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks and Trademark Licenses or unfair competition regarding the same; and assigns, transfers and conveys to Grantors any interest in all of the foregoing, including any lien and security interest thereof; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.


