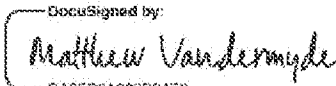
2. The Corporation's name and type of entity immediately prior to the filing of this Certificate of Conversion was Ten-X, Inc., a Delaware corporation.
