TERMINATION OF INTELLECTUAL PROPERTY SUPPLEMENT TO REVOLVING  
CREDIT AND SECURITY AGREEMENT AND RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL

This TERMINATION OF INTELLECTUAL PROPERTY SUPPLEMENT TO REVOLVING CREDIT AND SECURITY AGREEMENT AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release"), dated as of March 28, 2017, is made by and among PNC Bank, National Association ("PNC"), in favor of The Markets, LLC, a state of Washington limited liability company (the "Grantor") as follows:

WITNESSETH

WHEREAS, pursuant to an Intellectual Property Supplement to Revolving Credit and Security Agreement, dated as of June 30, 2010 (the "Security Agreement"), and recorded with the U.S. Patent and Trademark Office on July 26, 2010 at Reel/Frame No. 4247/0760, the Grantor granted to PNC a lien on and continuing security interest in, all of Grantor's right, title and interest in, to and under the "Collateral" (as defined and set forth therein) pledged by the Grantor described therein, including, without limitation, the United States trademarks set forth on Schedule A attached hereto (collectively, the "Trademarks") and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks;

WHEREAS, the Grantor has paid in full all of the indebtedness to PNC secured by such lien and security interest; and

WHEREAS, the Grantor has requested that PNC release of record PNC's lien on and continuing security interest in, all right, title and interest of PNC in and to the Collateral.

NOW, THEREFORE, PNC, without recourse, representation or warranty, hereby terminates, cancels and releases its lien on and continuing security interest in the Collateral, including the Trademarks, and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, and any and right, title and interest of PNC in the Collateral shall hereby terminate, cease and become void.

PNC agrees to provide the Grantor with any information and additional authorization and documentation necessary to effect the release of PNC's lien and security interest in the Collateral (without recourse, representation or warranty).
