Pursuant to the provisions of Sections 3.051 through 3.056 of the Texas Business Organizations Code, the undersigned hereby certifies as follows:

**ARTICLE ONE.**

The name of the corporation is PARKER SQUARED INC. ("Corporation"). The filing number issued by the Secretary of State of Texas for Corporation is 801139301 and Corporation's date of formation is June 25, 2009.

**ARTICLE TWO.**

The following amendments to the Certificate of Formation were adopted by the Directors of Corporation in accordance with the Texas Business Organizations Code and the Bylaws of Company:

- A. Article 2C of the Certificate of Formation is amended to change the registered agent and registered office address of Corporation and is to read as follows:

B. The shares shall have no par value.”

**ARTICLE THREE.**

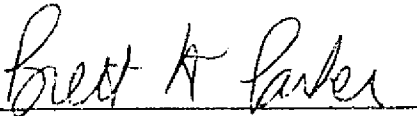
The amendments to the Certificate of Formation have been approved in the manner required by the Texas Business Organizations Code and by the governing documents of Corporation.
