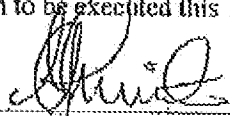
The undersigned, C. Alan Smith, hereby certifies that:

1. He is the President of Insulspan, Incorporated (the "Corporation"), a Delaware corporation, and is duly authorized by the unanimous written consent of the Board of Directors of the Corporation and is further authorized by the unanimous written consent of the sole shareholder to execute this instrument.
2. The present name of the Corporation is "Insulspan, Incorporated." The Corporation filed its Certificate of Incorporation with the Secretary of State of the State of Delaware on June 28, 2004 under the name Insulspan of America, Inc.
3. The Corporation changed its name to "Insulspan, Incorporated" pursuant to a Certificate of Merger as filed with the Secretary of State of the State of Delaware on November 5, 2004.
4. This Certificate of Amendment to the Certificate of Incorporation was duly approved by the Corporation's Board of Directors and duly adopted by the written consent of the sole shareholder of the Corporation in accordance with the applicable provisions of Section 228 and 242 of the General Corporation Law of the State of Delaware.
5. Article I of the Certificate of Incorporation is hereby amended to read in its entirety as follows:

ARTICLE I

The name of the Corporation is PIB America Corporation (herein the "Corporation").
