## RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST (this "Release") is given as of this 3rd day of December 2021, by SBJ FUND, LP, in its capacity as Collateral Agent ("Collateral Agent"), to UC GLAMPING PARTNERS LLC, a Delaware limited liability company, UNDER CANVAS INC., a Delaware corporation, and WEST YELLOWSTONE RANCH, LLC, a Montana limited liability company (collectively, the "Grantors"). This Release is executed in reference to the Amended and Restated Guaranty and Collateral Agreement, dated September 14, 2020 (the "GCA") and the Trademark Security Agreement dated October 30, 2020 (the "TSA"), between Grantors and Collateral Agent. All capitalized terms not defined in this Release shall have the meanings ascribed to them in the GCA and TSA, as applicable.

### BACKGROUND

A. Pursuant to the GCA and TSA, Grantors have granted to Collateral Agent a security interest in the Trademark Collateral, including those set forth on Schedule 1 attached hereto.

B. Grantors have on December 3, 2021, satisfied all of the Obligations the performance of which is secured by the Trademark Collateral, and therefore the security interest in the Trademark Collateral has been fully satisfied and discharged, and the parties wish to evidence and record the release of the security interest in the Trademark Collateral.

### RELEASE

In consideration of Grantors' satisfaction and discharge in full of the Obligations, by this Release, Collateral Agent (1) terminates its security interest in the Trademark Collateral, (2) fully releases and discharges all liens, security interests, right, title and interest it may have in and to the Trademark Collateral and (3) authorizes and requests that the United States Patent and Trademark Office note and record the release hereby given and any other filings necessary to evidence the release and termination of Collateral Agent's rights in the Trademark Collateral.
