RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, the Secured Party hereby agrees to execute any additional documents that are required to effect the intent of the parties, i.e., a release of the security interest in the Listed Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby releases its security interest in all of the Company's trademarks and trademark applications, including the Listed Trademarks, and the registrations thereof and the associated business goodwill therein and to any other rights it might have arising out of the Trademark Agreement.
