RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “**Release**”) is made as of December 6, 2021, by **WESTERN ALLIANCE BANK** (“**Bank**”), in favor of **MAVENLINK, INC.**, a Delaware corporation (“**Grantor**”).

WHEREAS, reference is hereby made to (a) that certain Loan and Security Agreement, dated as of August 20, 2019, as modified by that certain Loan and Security Modification Agreement, dated December 30, 2020 (as may be further amended, restated, supplemented, or otherwise modified), executed by Grantor in favor of Bank, (b) that certain security interest filing recorded at **Reel/Frame 6724/0568**, and (c) that certain security interest filing recorded at **Reel/Frame 6724/0568**; and

WHEREAS, pursuant to the above-referenced security agreements, Grantor granted to Bank a security interest in and continuing lien on all of Grantor’s right, title and interest in, to and under those trademarks set forth on Schedule A hereto (collectively, the “**Trademark Collateral**”).

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Bank hereby (i) terminates and releases all security interests and continuing liens granted by Grantor in favor of Bank in the Trademark Collateral; (ii) assigns, transfers and delivers to Grantor all of its right, title and interest in and to the Trademark Collateral to the extent that any such right, title and interest exists as of the date hereof; (iii) authorizes Grantor or its designee to make filings with the United States Patent and Trademark Office and to take further actions necessary to evidence the release and termination of Bank’s security interests in and liens on the Trademark Collateral; and (iv) authorizes the governing body of the United States Patent and Trademark Office to record this Release.
