TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (this “Termination and Release”) is granted as of October 1, 2021 by CAMBRIDGE TRUST COMPANY, (the “Grantee”) in favor of CONSUMER’S MEDICAL RESOURCE, INC a Massachusetts corporation (the “Grantor”).

WHEREAS, the Grantor executed and delivered a Grant of Security Interest in United States Trademarks dated as of June 30, 2017 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “**2017 Grant**”), granting the Grantee a security interest in and lien on certain trademarks and trademark applications described therein, which was recorded in the Trademark Assignment Division of the United States Patent and Trademark Office (“**USPTO**”) on July 5, 2017, at Reel 6098, Frame 0185;

WHEREAS, the Grantor executed and delivered a Supplement No 1. to Grant of Security Interest in United States Trademark dated as of August 4, 2020 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “**2020 Grant**”), granting the Grantee a security interest in and lien on certain trademarks and trademark applications described therein, which was recorded in the USPTO on August 5, 2020, at Reel 7023, Frame 0509;

WHEREAS, the Grantor has requested that the Grantee hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantor in, to and under all of the trademarks and trademark applications described in the 2017 Grant and the 2020 Grant (collectively, the “**Trademarks**”) as herein provided; and

WHEREAS, the Grantor has requested that the Grantee provide a document suitable for recording in the USPTO to evidence the release of its security interests in and liens on the Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby:

1. terminates the 2017 Grant and the 2020 Grant and releases, terminates and discharges all liens and security interests in the Grantor’s right, title and interest in, to and under (i) the Trademarks, including without limitation those trademarks and trademark applications identified in Exhibit A hereto, (ii) all proceeds and products of the Trademarks, (iii) all goodwill associated therewith, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Trademarks or unfair competition regarding the same; and assigns, transfers and conveys to Grantor any interest in all of the foregoing, including any lien and security interest thereof; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.

IN WITNESS WHEREOF, Cambridge Trust Company has caused this Termination and Release to be executed by its duly authorized officer as of the date above first written.





