3. The Assignor shall furnish the Assignee with all necessary information on and in connection with the Trademark, which may be required to perfect title in the Trademark in the Assignee.
4. This Agreement and all amendments, modifications, alterations, or supplements thereto, shall be construed under, governed by, and the legal relations between the Parties hereto determined in accordance with the laws of the State of North Carolina.
5. Each Party acknowledges that it has read this Agreement, understands it and agrees to be bound hereby, and represents and warrants that the individual executing this Agreement on its behalf is duly authorized to enter into this Agreement.

IN WITNESS WHEREOF, the Parties hereto have caused this Agreement to be executed on behalf of their duly authorized officers and representatives on the Effective Date.






