DEED OF ASSIGNMENT

THIS DEED OF ASSIGNMENT is made on November 23, 2021 ("**Effective Date**") between **Goliath Far East Limited** located at Suite 1106, 11th Floor, Chinachem Golden Plaza, 77 Mody Road, TST East, Kowloon, Hong Kong ("**Assignor**") and **Goliath IP Stichting**, a foundation under the laws of the Netherlands, located at Vijzelpad 80, 8051 KR Hattem, the Netherlands ("**Assignee**").



WHEREAS, under the terms of this Deed of Assignment, Assignor has conveyed, transferred, and assigned to Assignee, among other assets, certain trademarks of Assignor, and has agreed to execute and deliver this Deed of Assignment, for recording with the respective intellectual property and/or trademark offices.

NOW THEREFORE, the Assignor and Assignee agree as follows:

1. Assignment. In consideration of a sum of at least one U.S. dollar (\$1.00) and other good and valuable consideration, the receipt of which is acknowledged, Assignor assigns to Assignee hundred percent (100%) of its right, title, and interest in the trademarks listed in **Schedule 1**, together with the goodwill of the business connected with the use of these marks, for the entire term of the registration and any extensions that may issue therefrom. The right, title, interest and goodwill conveyed in this Assignment is to be held and enjoyed by Assignee and its successors as fully and exclusively as it would have been held and enjoyed by Assignor had this assignment not been made. This assignment includes any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Governing Law. This Deed of Assignment shall be governed by laws of the Netherlands and the parties hereto exclusively submit to the jurisdiction of the court of Amsterdam.
