The Assignor hereby warrants and undertakes that it will forthwith sign, upon request made by the Assignee, any further documentation that may be required to record the Assignee as the owner of the Marks at the United States Patent and Trademark Office or equivalent authority responsible for registering trademarks or recording ownership of trademarks.


