**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination and Release") is made as of the 29th of September, 2021, by CAPITAL ALIGNMENT PARTNERS III, L.P., a Delaware limited partnership ("Lender") to HIGHFIVE DENTAL HOLDCO, LLC, an Alabama limited liability company ("Debtor").

WITNESSETH:

WHEREAS, pursuant to that certain Loan and Security Agreement, dated as of February 28, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time), by and between Debtor and Lender, (i) Debtor executed that certain Memorandum of Security Agreement (Trademarks), dated as of February 28, 2020 (the "Trademark Security Agreement"), which Trademark Security Agreement was recorded in the United States Patent and Trademark Office ("USPTO") at Reel 006878, Frame 0493 on February 28, 2021, pursuant to which Borrower granted a security interest to Lender in the Trademarks (as defined in the Trademark Security Agreement), including certain trademarks and/or trademark applications listed on Schedule A attached hereto and made a part hereof (collectively, the "Trademark Collateral"); and

WHEREAS, Lender now desires to terminate and release its security interest in the Trademark Collateral and reassign any and all rights, title, and interest in the same to Debtor.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Lender releases its security interest in all of Debtor's right, title and interest in and to the Trademark Collateral, including those Trademarks set forth on Schedule A.

2. If and to the extent that Lender has acquired any right, title or interest in or to any of the Trademark Collateral, Lender hereby reassigns, grants and conveys to Debtor, without any representation, warranty, recourse or undertaking by Lender, any and all of its right, title, and interest in and to the Trademark Collateral (including without limitation those Trademarks set forth on Schedule A), along with any goodwill in the Trademark Collateral that Lender may have acquired.

3. This Termination and Release, and any claims, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of, or relating to this Termination and Release and the transactions contemplated hereby and thereby shall be governed by, and construed in accordance with, the law of the State of Delaware without regard to conflict of laws principles thereof.


