**Release of Security Interest in Trademarks**

This Release of Security Interest in Trademarks, dated as of December 1, 2021 (this “Release”), is made by BARCLAYS BANK PLC, as collateral agent (in such capacity, the “Collateral Agent”), in favor of CDW LLC, an Illinois limited liability company (the “Grantor”).

WHEREAS, by (i) that certain Second Amended and Restated Guarantee and Collateral Agreement, dated as of April 29, 2013 (amending and restating that certain Guarantee and Collateral Agreement, dated as of October 12, 2007, as amended and restated by that certain Amended and Restated Guarantee and Collateral Agreement, dated as of December 17, 2010), by and among CDW Corporation, a Delaware corporation, the Grantor, the subsidiaries of the Grantor from time to time party thereto and the Collateral Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”) and (ii) that certain Second Amendment to Trademark Security Agreement, dated as of April 29, 2013 (amending that certain Trademark Security Agreement, dated as of October 12, 2007, as amended by that certain First Amendment to Trademark Security Agreement, dated as of December 17, 2010), entered into by the Grantor in favor of the Collateral Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”; capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or the Trademark Security Agreement, as applicable), which Trademark Security Agreement was recorded with the United States Patent and Trademark Office on (i) December 20, 2010 at Reel 004436 Frame 0630 (First Amendment) and (ii) April 29, 2013 at Reel 5016 Frame 0426 (Second Amendment), the Grantor granted to the Collateral Agent, for the benefit of the Secured Parties, a lien on and security interest in all of the Grantor’s right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), including those Trademarks listed on Schedule I hereto;

WHEREAS, the Grantor desires the Collateral Agent to release, discharge, terminate and cancel its lien on and security interest in the Trademark Collateral of the Grantor, including, without limitation, the Trademarks set forth on Schedule I hereto; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent, on behalf of the Secured Parties, does hereby release, discharge, terminate and cancel any and all of its right, title and interest in and to the Trademark Collateral of the Grantor, including any and all goodwill relating to the same, and assigns, transfers and conveys to the Grantor any and all of its rights, title and interests in the Trademark Collateral.

The Collateral Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.


