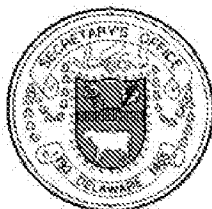

Pursuant to Title 8, Section 251 of the Delaware General Corporation Law, the undersigned corporation executed the following Certificate of Merger:

FIRST. The name of the surviving corporation is Building Robotics, Inc., a Delaware corporation (the "Surviving Corporation"), and the name of the corporation being merged into this Surviving Corporation is Enlighted, Inc., a Delaware corporation (the "Merged Corporation").

SECOND. An Agreement and Plan of Merger and Reorganization has been approved and adopted by the sole shareholder of the Merged Corporation.
