**RELEASE OF SECURITY INTEREST AND REASSIGNMENT OF
TRADEMARKS**

Reference is hereby made to that certain Trademark Security Agreement, dated as of October 31, 2019 (the "Agreement"), by and among BL RANKINGS, LLC, a New York limited liability company ("Company") and DEERPATH FUND SERVICES, LLC, a Delaware limited liability company, as administrative agent and collateral agent ("Agent"), which was recorded in the United States Patent and Trademark Office on October 31, 2019 at Reel 6783, Frame 0804, pursuant to which the Company granted to Agent a continuing security interest in and lien on all of the Trademark Collateral as defined in the Agreement including those trademarks specifically listed on Schedule 1 attached hereto (collectively, the "Released Trademark Collateral");

WHEREAS, the Obligations (as defined in the Agreement) have been paid in full and Agent wishes to terminate the Agreement, release said continuing security interest in and lien on the Released Trademark Collateral, and retransfer and reassign to the Company, without representation or warranty, all of Agent's right, title and interest in and to the Released Trademark Collateral (if any);

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Agent hereby terminates the Agreement, releases said continuing security interest in and lien on the Released Trademark Collateral, and retransfers and reassigns to the Company, without representation or warranty, all of Agent's right, title and interest in and to the Released Trademark Collateral (if any).


The Agent acknowledges and authorizes the recordation of this document with the United States Patent and Trademark Office to evidence the termination and release granted therein.
