TRADEMARKS

This TERMINATION AND RELEASE OF GRANT OF A SECURITY INTEREST -- TRADEMARKS (“Termination and Release”) dated as of December 9, 2021, is from UBS AG, STAMFORD BRANCH, as administrative agent (the “Administrative Agent”) to TRC COMPANIES, INC. and TRC PIPELINE SERVICES, LLC (collectively, the “Trademark Grantors”). Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Credit Agreement, the Security Agreement or the Trademark Security Agreements, as applicable.

WITNESSETH:

WHEREAS, pursuant to that certain Security Agreement, dated as of June 21, 2017, the Trademark Grantors executed (i) a Trademark Security Agreement, dated as of June 21, 2017, which was recorded in the United States Patent and Trademark Office at Reel 006089, Frame 0016 and (ii) a Trademark Security Agreement, dated as of December 21, 2017, which was recorded in the United States Patent and Trademark Office at Reel 006232, Frame 0073, pursuant to which the Trademark Grantors granted a security interest to the Administrative Agent, for the benefit of the Secured Parties, in the Trademark Collateral (as defined in the applicable Trademark Security Agreement), including certain trademarks and/or trademark applications listed on Schedule A hereto and made a part hereof.

WHEREAS, the Administrative Agent now desires to terminate and release its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Administrative Agent hereby terminates, cancels and releases any and all of its security interest in all of Trademark Grantors’ right, title and interest in and to the Trademark Collateral.
2. Administrative Agent shall take all further actions, and provide to the Trademark Grantors and their respective successors, assigns or other legal representatives all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by the Trademark Grantors to more fully and effectively effectuate the purposes of this releases.
