RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This Release of Intellectual Property ("Release") is made effective as of December 2, 2021 by BANK OF AMERICA, N.A., in its capacity as administrative agent for the Lenders (the "Administrative Agent"), to MATSON ALARM CO., INC. (the "Grantor"), as follows:

WHEREAS, pursuant to that certain Security Agreement (the "Agreement"), dated as of November 1, 2019, the Grantor granted to the Administrative Agent a security interest in intellectual property as security for loans and other obligations;

WHEREAS, pursuant to the Agreement, the Grantor and Administrative Agent entered into a Notice of Grant of Security Interest in Trademarks, dated as of November 4, 2019 (the "Notice"), pursuant to which the Grantor granted to the Administrative Agent a continuing security interest in, and a right to set off against, the trademarks and trademark applications shown on Schedule A (collectively, the "Collateral") attached hereto to the Administrative Agent for the ratable benefit of the Secured Parties (as defined in the Agreement);

WHEREAS, the Notice was recorded in the United States Patent and Trademark Office on November 1, 2019 at Reel 6786 / Frame 0712;

WHEREAS, the Administrative Agent wishes to release its security interest in the Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

1. Release. The Administrative Agent hereby, without warranty as to status of title or priority of the encumbrances being hereby released, releases, discharges, terminates and cancels all right, title and interest in, to and under the Collateral, including, without limitation, any security interest it may have in the Collateral and the goodwill of the business connected with the use of, and symbolized by, the Collateral, and retransfers and reassigns any and all right, title, and interest it may have in the foregoing without recourse solely as to the Grantor.


2. Termination. The Administrative Agent, without any recourse, statement, representation and warranty, promise or undertaking whatsoever, hereby terminates and cancels the Agreement.

3. Further Assurances. At the request and expense of the Grantor, the Administrative Agent hereby agrees to perform all other and further acts, and provide to the Grantor and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor to retransfer and reassign any and all right, title and interest it may have in the Collateral without recourse to the Grantor.
