**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (“Release”), effective as of this 9th day of December 2021, is made by **U.S. BANK NATIONAL ASSOCIATION**, as collateral agent (in such capacity, the “Collateral Agent”), in favor of **INTELIQUENT, INC., ONVOY, LLC, BROADVOX, LLC, LAYERED COMMUNICATIONS LLC** and **ANPI, LLC** (each, a “Grantor”, and collectively, the “Grantors”), as follows:

**WITNESSETH**

WHEREAS, each Grantor or its affiliates and the Collateral Agent are party to that certain Second Lien Credit Agreement, dated as of February 10, 2017 (as amended, supplemented or otherwise modified from time to time, the “Credit Agreement”);

WHEREAS, in connection with the Credit Agreement, each Grantor executed that certain Second Lien Collateral Agreement, dated as of February 10, 2017 (as amended, supplemented or otherwise modified from time to time, the “Collateral Agreement”), and granted to the Collateral Agent, among other Collateral as defined and set forth in the Collateral Agreement, a security interest in and to all of such Grantor’s right, title and interest in all trademarks and trademark licenses, including as set forth on Schedule I attached hereto (collectively, the “Trademarks”), including all goodwill of the business connected with the use of, and symbolized by, each Trademark to secure the Obligations (as defined in the Credit Agreement);

WHEREAS, in furtherance of the Collateral Agreement, each Grantor executed the Trademark Security Agreement, dated February 10, 2017 (the “Trademark Security Agreement”), which was duly recorded on February 10, 2017, at Reel/Frame 5987/0211 in the United States Patent and Trademark Office;

WHEREAS, the Collateral Agent wishes to release and restore all right, title and interest in and to the Trademarks to the Grantors and to dissolve those liens and encumbrances created by the Trademark Security Agreement and the Collateral Agreement in respect of the Trademarks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Collateral Agent hereby grants, assigns, transfers and conveys, without recourse or warranty, to the Grantors all of its rights, title and interest in its Trademarks, including any goodwill associated therewith, and terminates, releases, discharges, quitclaims and relinquishes unto the Grantors any and all security interests and liens it has against the Trademarks.

The Collateral Agent hereby agrees, at the Grantors’ sole cost and expense, to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the intents and purposes of this Release.
