Please be advised that pursuant to the Pledge and Security Agreement dated as of August 10, 2021 (as amended by that certain Joinder to Loan Documents dated as of December 8, 2021 and as may be further amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Agreement”) among the undersigned Alert 360 Opco, Inc., a Delaware corporation, with its principal address at 2448 E 81st St, Ste. 4300, Tulsa, Oklahoma, 74137, Central Security Group – Nationwide, Inc., a Delaware corporation, with its principal address at 2448 E 81st St, Ste. 4300, Tulsa, Oklahoma, 74137, and Guardian Security Systems, Inc., an Oklahoma corporation with its principal address at 2448 E 81st St, Ste. 4300, Tulsa, Oklahoma, 74137 (each individually a “Grantor” and collectively, the “Grantors”), the other grantors party thereto and PLC Agent LLC, a Delaware limited liability company with its principal address at 18 Shipyard Drive, Suite 2C, Hingham, MA 02042, as collateral agent (the “Collateral Agent”) for the Secured Parties, the undersigned Grantors have granted to the Collateral Agent, for the benefit of the Secured Parties, a continuing security interest in any and all right, title and interest of such Grantor in and to the Trademarks on Schedule 1 hereto including without limitation (i) all proceeds and products of the Trademarks, (ii) the goodwill of the businesses with which the Trademarks are associated and (iii) all causes of action arising prior to or after the date hereof for infringement of any of the Trademarks or unfair competition regarding the same (collectively, the “Trademark Collateral”). This Notice of Grant of Security Interest in Trademarks has been entered into in accordance with the provisions of the Agreement. The undersigned Grantor does hereby acknowledge and confirm that the security interest referenced hereunder to, and the rights and remedies of, the Collateral Agent with respect to the Trademark Collateral are more fully set forth in the Agreement.


