TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT (this “*Release*”) is made as of December 9, 2021, by BMO Harris Bank N.A., in its capacity as administrative agent for itself and the other Lenders (in such capacity, “*Administrative Agent*”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, Basys LLC, a Maryland limited liability company (“*Grantor*”), was party to that certain Trademark Security Agreement, dated as of July 18, 2018, in favor of Administrative Agent (the “*Security Agreement*”), pursuant to which Grantor granted to Administrative Agent a continuing security interest in and lien on the Trademarks listed on the attached Schedule A (the “*Subject Trademarks*”);

WHEREAS, the Security Agreement was recorded by the United States Trademark and Trademark Office on July 18, 2018, at Reel 6410, Frame 0025;

WHEREAS, Grantor has requested that Administrative Agent release its security interest in and lien on the Subject Trademarks and reassign any and all rights in the same to Grantor; and

WHEREAS, Grantor has satisfied and fulfilled all of its obligations to release Administrative Agent’s security interest in and lien on the Subject Trademarks.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby agrees as follows:

1. Administrative Agent hereby fully releases, discharges, terminates and cancels its liens and security interest in all right, title and interest in, to and under the Subject Trademarks and all proceeds thereof.

2. Administrative Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Administrative Agent, any and all of Administrative Agent’s right, title and interest in and to the Subject Trademarks and hereby terminates the Security Agreement.

3. GOVERNING LAW. THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
