**FIRST LIEN TERMINATION AND RELEASE  
OF SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (this “*Trademark Release*”) is made as of December 10, 2021, by HPS INVESTMENT PARTNERS, LLC, a Delaware limited liability company (the “*Administrative Agent*”) in favor of DONLIN, RECANO & COMPANY, INC., a New York corporation, and D.F. KING & CO., INC., a Delaware corporation (each a “*Grantor*”, and collectively, the “*Grantors*”). Capitalized terms used but not otherwise defined herein have the meanings given to them directly or by reference in the Trademark Security Agreement.

W I T N E S S E T H:

**WHEREAS**, pursuant to that certain First Lien Guarantee and Collateral Agreement, dated as of July 2, 2018, by and among the Administrative Agent, the Grantors and certain other parties (as may have been amended, supplemented or otherwise modified, the “*Collateral Agreement*”), the Grantors entered into a certain First Lien Trademark Security Agreement, dated as of July 2, 2018 (the “*Trademark Security Agreement*”) with the Administrative Agent, which was recorded on July 3, 2018 at the United States Patent and Trademark Office (“*USPTO*”) at Reel 6371, Frame 0692;

**WHEREAS**, pursuant to the Collateral Agreement and Trademark Security Agreement, each Grantor granted to the Administrative Agent and its successors and assigns, for the benefit of the Secured Parties, a security interest (the “*Security Interest*”) in all of its right, title or interest in or to: (i) all then owned or thereafter acquired trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, all registrations and recordings thereof, and all registration and recording applications filed in connection therewith, including registrations and registration applications in the United States Patent and Trademark Office or any similar offices in any State of the United States of America or any other country or any political subdivision thereof, and all extensions or renewals thereof, including those listed on Schedule I attached hereto, (ii) all goodwill associated therewith or symbolized thereby, and (iii) all other assets, rights and interests that uniquely reflect or embody the foregoing (collectively, the “*Trademark Collateral*”); and

**WHEREAS**, the Administrative Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.


**NOW, THEREFORE**, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, the Administrative Agent, for itself and on behalf of the Secured Parties, hereby (i) releases, terminates and discharges the Security Interest, in the Trademark Collateral, and (ii) assigns, transfers and conveys to each Grantor, as applicable, any and all right, title and interest it may have in the Trademark Collateral of such Grantor.

Each Grantor, and any successor to such Grantor (including any person or entity hereafter holding any right, title or interest in or to the Trademark Collateral of such Grantor), is hereby authorized to record this Trademark Release at the USPTO.
