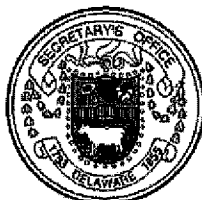


**CERTIFICATE OF MERGER

The undersigned, for the purpose of causing a Delaware limited liability company to be merged with and into First Financial Bank, an Ohio corporation, pursuant to Section 18-209 of the Delaware Limited Liability Company Act (the "Delaware LLC Act"), DOES HEREBY CERTIFY THAT:

- FIRST:** The name of the surviving corporation is First Financial Bank, a corporation organized and existing under the laws of the State of Ohio (the "Surviving Corporation").
- SECOND:** The name of the limited liability company being merged into the Surviving Corporation is Wallace Merger Sub LLC, a Delaware limited liability company (the "Merging LLC").
- THIRD:** An Agreement and Plan of Merger has been adopted, approved, certified, executed and acknowledged by each of the Surviving Corporation and the Merging LLC in accordance with the respective provisions of Section 18-209 of the Delaware LLC Act and the applicable provisions of the Ohio General Corporation Law.
- FOURTH:** The merger of the Merging LLC with and into the Surviving Corporation shall be effective on August 30, 2019 at 11:59 p.m., Eastern Daylight Time.
- FIFTH:** The executed Agreement and Plan of Merger is on file at the principal place of business of the Surviving Corporation, the address of which is 255 East Fifth Street, Suite 2900, Cincinnati, Ohio 45202.
- SIXTH:** A copy of the executed Agreement and Plan of Merger will be furnished by the Surviving Corporation, on request and without cost, to any member of the Merging LLC and to any shareholder of the Surviving Corporation.
- SEVENTH:** The Surviving Corporation agrees that it may be served with process in the State of Delaware in any action, suit or proceeding for the enforcement of any obligation of the Merging LLC, irrevocably appointing the Delaware Secretary of State as the agent of the Surviving Corporation to accept service of process in any such action, suit or proceeding, and the address to which a copy of such process shall be mailed by the Delaware Secretary of State is 255 East Fifth Street, Suite 2900, Cincinnati, Ohio 45202.
