**U.S. TRADEMARKS RELEASE OF SECURITY INTEREST**

This Trademark Security Agreement Release (the "Release") is entered into and effective as of the execution date below (the "Effective Date") by Bell Bank, a North Dakota banking corporation (the "Lender") in favor of Pebble Technology, Incorporated, an Arizona corporation (the "Grantor").

WHEREAS, pursuant to that certain Loan and Security Agreement (the "IP Security Agreement") entered into by the parties as of September 28, 2018, the Grantor granted to Lender a security interest in certain intellectual property of the Grantor, including the Trademarks identified on Schedule A attached hereto (the "Specified Intellectual Property");

1. The Lender hereby releases in its entirety to the Grantor its security interest in, to and under the Specified Intellectual Property.
2. The Lender hereby authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release, in each case at the sole cost and expense of the Grantor.
