GRANT OF SECURITY INTEREST
IN UNITED STATES TRADEMARKS

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, this Trademark Security Agreement, dated as of September 30, 2021 is made by the entity listed on the signature pages hereto, a California limited liability company with its chief executive office at 6131 Innovation Way, Carlsbad, CA 92009(the "Grantor") in favor of the Agent (as defined below) in order to induce the Lenders under the Credit Agreement (as defined below) to make extensions of credit to the Borrower (as defined below), pursuant to (i) the Credit Agreement, dated as of as of May 10, 2021, among Monolith Brands Holdco, LLC, a Delaware limited liability company, Monolith Brands, LLC, a Delaware limited liability company (the "Borrower"), any Co-Borrower or Guarantor (as defined therein), the Lenders (as defined therein) from time to time party thereto, and Coventure – Monolith Credit Opportunities GP, LLC ("Coventure"), as administrative agent and collateral agent ("Agent") (as amended, restated supplemented or otherwise modified from time to time, the "Credit Agreement"), and (ii) the Security Agreement, dated as of May 10, 2021, in connection with the Credit Agreement (as amended, restated supplemented or otherwise modified from time to time, the "Security Agreement"), a joinder to which has been executed and delivered by Grantor in favor of the Agent, and under which the Grantor pledged and granted to Coventure, as Agent, a continuing security interest in all of Grantor's Intellectual Property. Grantor hereby pledges and grants a continuing security interest in, to and under all of Grantor's right, title and interest in each United States Trademark owned by it, including all common law rights therein, and all goodwill appurtenant thereto and symbolized thereby (including, without limitation, those items set forth on Schedule A attached hereto) ("Trademarks") for the benefit of the Credit Parties to secure the payment, performance and observance of the Obligations. Notwithstanding anything to the contrary hereunder, the security interest created by this Grant of Security Interest in United States Trademarks shall not extend to any United States Trademark consisting of intent-to-use trademark applications, for which the creation by a Grantor of a security interest therein is prohibited without the consent of third party or by applicable Law.

Unless otherwise defined herein or the context otherwise requires, terms used herein have the meanings provided or provided by reference in the Credit Agreement and the Security Agreement (as applicable).

This grant of security interest in United States Trademarks (this "Grant") has been executed and delivered by the Grantor for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office. Grantor authorizes and requests that the Commissioner for Trademarks record this Grant. The security interest granted hereby has been granted to the Agent for the benefit of the Credit Parties in connection with the Security Agreement and is expressly subject to the terms and conditions thereof. The rights and remedies of the Agent with respect to the security interest granted herein are as set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.

This Grant may be executed in any number of counterparts and by different parties hereto in separate counterparts, each of which shall be deemed to be an original, but all of which when taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Grant by telecopier, facsimile or other electronic means shall be effective as delivery of a manually executed counterpart of this Grant.
