**RELEASE OF TRADEMARK SECURITY INTEREST**

This **RELEASE OF TRADEMARK SECURITY INTEREST**, dated as of December 13, 2021 (this “**Release**”), is made by **WHITE OAK COMMERCIAL FINANCE, LLC**, as Administrative Agent, Collateral Agent and Swing Line Lender (“**Agent**”), in favor of **THE RUNNING SPECIALTY GROUP ACQUISITIONS 1, LLC**, an Indiana limited liability company, **CLEVER TRAINING OPERATING CO., LLC**, a Delaware limited liability company, **OLYMPIA SPORTS ACQUISITIONS, LLC**, a Delaware limited liability company, and **PROJECT SAGE ACQUISITION, LLC**, a Delaware limited liability company (collectively, “**Grantors**”).

**WHEREAS**, pursuant to that certain Grant of Security Interest in Trademarks dated as of May 28, 2021, between Grantors and Agent (the “**Security Agreement**”), Grantors granted to Agent a continuing security interest in all right, title and interest of Grantors in and to the Trademark Collateral (as defined in the Security Agreement), including the trademarks identified on the attached Schedule A; and

**WHEREAS**, the security interests identified herein were recorded with the United States Patent and Trademark Office (“**USPTO**”) on June 2, 2021, at Reel 7314 Frame 0371.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent and Grantors agree as follows:

**SECTION 1. Defined Terms**. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement referenced in the preamble and recitals hereto.

**SECTION 2. Termination and Release**. Agent without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:

(a) terminates, cancels, discharges and releases the continuing security interest in, Grantors’ right, title, and interest in and to the trademarks identified on Schedule A attached hereto, granted pursuant to the Security Agreement; and


(b) authorizes the recordation of this Release with the USPTO at Grantors’ expense.

**SECTION 3. Choice of Law**. This Release shall be governed by and construed in accordance with the laws of the State of New York.
