RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of December 14, 2021 (the "Effective Date"), is made by Cerberus Business Finance, LLC, a Delaware limited liability company (the "Releasor"), in favor of Thomas Scientific, LLC (the "Releasee").

WHEREAS, pursuant to that certain Pledge and Security Agreement, dated January 22, 2018 (the "Security Agreement"), Releasee assigned to Releasor and granted to Releasor, for the benefit of the Secured Parties, a continuing security interest in all right, title and interest of Releasee in, to and under the trademarks and service marks listed on Schedule A attached hereto, which trademarks and service marks are registered or applied for in the United States Patent and Trademark Office (the "Trademarks"), together with, among other things, the good-will of the business symbolized by the Trademarks, and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Collateral").

WHEREAS, pursuant to that certain Assignment for Security -- Trademarks, dated May 4, 2018, recorded in the United States Patent and Trademark Office on May 4, 2018 at Reel 006379, Frame 0648 (the "Trademark Security Agreement"), Releasee pledged, conveyed, sold, assigned, transferred and set over unto the Releasor and granted to the Releasor for the benefit of the Releasor and the Secured Parties, a continuing security interest in the Collateral; and

WHEREAS, Releasee has requested, and Releasor wishes to provide, a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of its security interest in the Collateral.


NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement or the Security Agreement.

2. Release of Security Interest. Releasor, without representation, warranty or recourse, hereby releases, relinquishes, terminates, cancels and discharges its security interest in the Collateral.

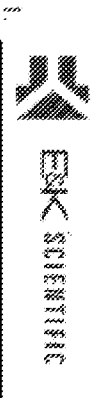
