**RELEASE OF FIRST AMENDMENT TO TRADEMARK SECURITY AGREEMENT**

THIS RELEASE OF FIRST AMENDMENT TO TRADEMARK SECURITY AGREEMENT ("Release"), dated as of October 12, 2021, is made by KEYBANK NATIONAL ASSOCIATION ("Lender"), for its benefit and for the benefit of each of its Affiliates (collectively, "Secured Party"), and is as follows:

WHEREAS, Secured Party and ASSURECARE, LLC, an Ohio limited liability company ("Debtor") are parties to that certain First Amendment to Trademark Security Agreement, dated as of June 19, 2020 (the "Agreement"), which was recorded with The United States Patent and Trademark Office on August 3, 2020, in its records at Reel 007013, Frame 0430-0435. Capitalized terms used, but not defined, herein shall have the meanings given to them in the Agreement;
