## RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT ("Release"), dated as of October 12, 2021, is made by KEYBANK NATIONAL ASSOCIATION ("Lender"), for its benefit and for the benefit of each of its Affiliates (collectively, "Secured Party"), and is as follows:

WHEREAS, Secured Party and ASSURECARE, LLC, an Ohio limited liability company ("Debtor") are parties to that certain Trademark Security Agreement, dated as of February 26, 2018 (the "Agreement"), which was recorded with The United States Patent and Trademark Office on March 7, 2018, in its records at Reel 006286, Frame 0123-0129.
