**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of December 15, 2021, by **TRUIST BANK** (successor by merger to SunTrust Bank), a North Carolina banking corporation (the “Collateral Agent”) in favor of **MYPOINTS.COM, LLC**, a California limited liability company with an address at 100 N. Sepulveda Boulevard, 8<sup>th</sup> Floor, El Segundo, California 90245, and **PRODEGE LLC**, a California limited liability company with an address at 2108 Vail Avenue, Redondo Beach, California 07055 (each a “Grantor”, and collectively, the “Grantors”).

WITNESSETH:

WHEREAS, the Grantors entered into a Short Form Intellectual Property Security Agreement dated November 20, 2018 with the Collateral Agent, notice of which was recorded on November 20, 2018 at the United States Patent and Trademark Office at Reel 6486, Frame 0578 (the “IP Security Agreement”).

Capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement.

WHEREAS, each Grantor granted the Collateral Agent, under the terms of the IP Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to all of such Grantor’s right, title and interest in, to and under the Collateral, including without limitation each such Grantor’s Trademarks listed in Schedule A (collectively, the “Trademark Collateral”).

WHEREAS, the Collateral Agent has agreed to terminate and release its Security Interest in the Trademark Collateral, including the Trademarks listed in Schedule A as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral, including the Trademarks listed in Schedule A hereto, and assigns, transfers and conveys to Grantors the Security Interest.
