**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 15, 2021 (“Release”), is made by CHURCHILL AGENCY SERVICES LLC, as administrative agent (“Agent”) in favor of SCIENS BUILDING SOLUTIONS, LLC, a Delaware limited liability company (the “Borrower”), and CEN-CAL FIRE SYSTEMS, INC., a California corporation (“Cen-Cal”, and together with the Borrower, each an “Obligor”, and collectively, the “Obligors”).

WHEREAS, pursuant to (i) that certain Guaranty and Security Agreement dated as of June 1, 2021 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Security Agreement”) by and among the Obligors, SCIENS HOLDINGS, INC., a Delaware corporation, Agent, and others party thereto, (ii) that certain Trademark Security Agreement dated as of June 1, 2021 by and among the Borrower and Agent (the “Sciens Trademark Security Agreement”), and (iii) that certain Trademark Security Agreement dated as of October 15, 2021 by and among Cen-Cal and Agent (the “Cen-Cal Trademark Security Agreement”, and together with the Sciens Trademark Security Agreement, the “Trademark Security Agreements”), the Obligors granted to Agent, for the benefit of the Secured Parties, a continuing security interest in any and all right, title and interest of Obligors in and to all Trademark Collateral; and

WHEREAS, the Sciens Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on June 2, 2021 at Reel 7313 Frame 0831.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent, on behalf of the Secured Parties, and Obligors agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or the Trademark Security Agreements.

SECTION 2. Termination and Release. Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

- (a) terminates the Trademark Security Agreements and terminates, cancels, discharges, and releases the continuing security interest in, and any and all right, title and interest of Obligors in and to, all of the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto;
- (b) reassigns, grants and conveys to Obligor any and all of Agent’s right, title and interest in and to the Trademark Collateral; and
- (c) authorizes the recordation of this Release with the USPTO at Obligors’ expense.

SECTION 3. Further Actions. Agent agrees to take all further actions, and provide to the Obligors and their respective successors, assigns or other legal representatives, all such cooperation and assistance reasonably requested by any Obligor, at the applicable Obligor’s sole cost and expense, to more fully and effectively effectuate the purpose of this Release.

SECTION 4. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York, without regarding to conflicts of law or choice of law principles.

IN WITNESS WHEREOF, Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
