**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of December 15, 2021, by **TRUIST BANK** (successor by merger to SunTrust Bank), a North Carolina banking corporation (the “Collateral Agent”) in favor of **INBOXDOLLARS, LLC** (f/k/a INBOXDOLLARS, INC.), a California limited liability company with an address at 100 N. Pacific Coast Highway, 8th Floor, El Segundo, California 90245 (the “Grantor”).

WITNESSETH:

WHEREAS, the Grantor entered into a Security Agreement Supplement for Intellectual Property dated July 15, 2019 with the Collateral Agent, notice of which was recorded on July 24, 2019 at the United States Patent and Trademark Office at Reel 6702, Frame 0527 (the “IP Security Agreement”).

Capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement.

WHEREAS, the Grantor granted the Collateral Agent, under the terms of the IP Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to all of its right, title and interest in, to and under the Collateral, including without limitation the Trademarks listed in Schedule A (collectively, the “Trademark Collateral”).

WHEREAS, the Collateral Agent has agreed to terminate and release its Security Interest in the Trademark Collateral, including the Trademarks listed in Schedule A as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral, including the Trademarks listed in Schedule A hereto, and assigns, transfers and conveys to Grantor the Security Interest.
