**RELEASE OF TRADEMARK SECURITY AGREEMENT**

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT is dated December 8, 2021, by JPMorgan Chase Bank (the "*Lender*").

**WITNESSETH:**

WHEREAS, Lender and Footprint Acquisition LLC ("*Grantor*"), are parties to a certain Trademark Security Agreement dated as of July 6, 2015 ("*Trademark Security Agreement*"), which was recorded in the United States Patent and Trademark Office on July 8, 2015, at Reel 5571, Frame 0333, pursuant to which the Grantor granted a security interest in and collateral assignment of certain trademarks, trademark registrations and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the "*Trademarks*"); and

WHEREAS, the Grantor has requested that the Lender release its security interests in the Trademarks and reassign the same to the Grantor;


