**RELEASE OF SECURITY INTEREST IN CERTAIN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN CERTAIN TRADEMARKS (this “Release”) is made as of December 15, 2021 (“Effective Date”) by CITIZENS BANK, N.A., as Administrative Agent (the “Administrative Agent”), to RIBBON COMMUNICATIONS OPERATING COMPANY, INC. (the “Grantor”).

WHEREAS, the Administrative Agent and the Grantor are parties to (i) that certain Guarantee and Collateral Agreement, dated as of March 3, 2020 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Guarantee and Collateral Agreement”) and (ii) that certain Trademark Security Agreement, dated as of March 3, 2020 (the “Trademark Security Agreement”);

WHEREAS, pursuant to the Guarantee and Collateral Agreement and the Trademark Security Agreement, the Grantor granted to the Administrative Agent a security interest in all of the Grantor’s right, title and interest in, to and under the Trademarks (as defined in the Trademark Security Agreement) other than any intent to use application at the United States Patent and Trademark Office with respect to intellectual property to the extent an assignment for security purposes would be rendered invalid, abandoned, void or impair the validity or enforceability of such intent to use application (collectively, the “Trademark Collateral”);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on March 3, 2020 at Reel Frame 6880/0747;

WHEREAS, the Grantor has sold all right, title and interest in and to the Trademarks listed on Schedule A hereto (the “Released Trademark Collateral”); and

WHEREAS, the Grantor has requested that the Administrative Agent execute and deliver this Release in order to evidence the release of the security interest granted in and recorded against the Released Trademark Collateral.


NOW THEREFORE, in consideration of the premises, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby (i) unconditionally, irrevocably and absolutely terminates, extinguishes, cancels, releases and forever discharges the security interest in the Released Trademark Collateral, and (ii) reassigns and transfer to the Grantor any and all right, title or interest (if any) that the Administrative Agent may have in or to any of the Released Trademark Collateral.

This Release is applicable solely with respect to the Released Trademark Collateral and to no other Trademark Collateral arising under the Guarantee and Collateral Agreement or the Trademark Security Agreement. Except as to the Released Trademark Collateral, the Guarantee and Collateral Agreement and the Trademark Security Agreement shall continue to be in full force and effect.

The Administrative Agent hereby authorizes the Grantor (or its designee) to file this Release with the United States Patent and Trademark Office and requests that the United States Patent and Trademark Office record this Release.
