**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN  
TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Termination and Release"), dated as of December 16, 2021, is made by ARES CAPITAL CORPORATION, in its capacity as agent for certain secured parties, as pledgee, assignee and a secured party (in such capacities, the "Agent") under the Second Lien Credit Agreement (as defined below).

WITNESSETH:

WHEREAS, reference is made to that certain Second Lien Credit Agreement, dated as of June 1, 2015 (as amended, restated, supplemented and/or otherwise modified from time to time, the "Second Lien Credit Agreement") among NAS, LLC ("NAS"), Nationwide Marketing Group, LLC ("NMG") and Nationwide Administrative Services, Inc. ("NWAS", and together with NAS and NMG, the "Borrowers"), the financial institutions from time to time party thereto (together with their respective successors and assigns, "Lenders") and Ares Capital Corporation, as agent for the Lenders (the "Agent"), the Loan Parties party thereto, the Lenders party thereto and the Agent;

WHEREAS, pursuant to the Trademark Security Agreement, dated as of October 20, 2017 (the "Trademark Security Agreement"), and pursuant to the Second Lien Guarantee and Collateral Agreement dated June 1, 2015, made by the Grantors to the Agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement") a lien on and security interest (the "Security Interest") was granted by the Grantors to the Agent in certain collateral, including the Trademarks;

WHEREAS, the Trademark Security Agreement was sent for recording in the United States Patent and Trademark Office on October 23, 2017 and was recorded in the Trademark Division of the United States Patent and Trademark Office on October 23, 2017 on Reel 6188, Frame 0412;

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademarks, including those Trademarks listed on Schedule 1 hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby agrees as follows:

1. Definitions. Capitalized terms not defined herein have the meanings set forth in the Trademark Security Agreement or the Security Agreement, as applicable.


2. Release of Security Interest. The Agent, without representation, warranty or recourse, hereby terminates, releases and discharges any and all Security Interest in the Trademarks, and any right, title or interest of the Agent in such Trademarks shall hereby cease and become void. For the avoidance of doubt, this Termination and Release applies solely to the security interest described in the Trademark Security Agreement and the Security Agreement and does not release any subsequent grant to Agent of a security interest in the Trademarks.

3. Recordation. The Agent authorizes the Borrowers and their designees to record this Termination and Release with the United States Patent and Trademark Office or any other applicable governmental authority at the Borrowers' expense.
