NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels the Grants and any other right, title, or interest granted to the Agent in the trademarks set forth on Schedule 1 attached hereto.


