RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of December 17, 2021 (the “Effective Date”), is made by BANK OF AMERICA, N.A., in its capacity as Collateral Agent (the “Collateral Agent”), in favor of the grantor parties identified on the signature page hereto (the “Grantors”).

WHEREAS, pursuant to that certain Second Lien Security Agreement, dated as of August 25, 2017 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), the Grantor granted to the Collateral Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, Johnny on The Spot Delivery, Inc. and Johnny on the Spot Surf Products LLC executed and delivered a Second Lien Trademark Security Agreement, dated as of August 25, 2017 (the “Johnny Trademark Security Agreement”), Rinehart’s Sanitation Services, Inc. executed and delivered a Second Lien Trademark Security Agreement, dated as of August 25, 2017 (the “Rinehart’s Trademark Security Agreement”), United Site Services, Inc. executed and delivered a Second Lien Trademark Security Agreement, dated as of August 25, 2017 (the “USS Trademark Security Agreement”) and Russell Reid Waste Hauling and Disposal Service Co., Inc. and M.W. Enterprises, Inc. executed and delivered a Second Lien Trademark Security Agreement, dated as of February 28, 2019 (the “2019 Trademark Security Agreement” and together with the Johnny Trademark Security Agreement, the Rinehart’s Trademark Security Agreement and the USS Trademark Security Agreement, the “Trademark Security Agreements”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Johnny Trademark Security Agreement was recorded with the United States Patent and Trademark Office on August 30, 2017 at Reel/Frame 6141/0699, the Rinehart’s Trademark Security Agreement was recorded with the United States Patent and Trademark Office on August 30, 2017 at Reel/Frame 6141/0710, the USS Trademark Security Agreement was recorded with the United States Patent and Trademark Office on August 30, 2017 at Reel/Frame 6141/0718 and the 2019 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on March 4, 2019 at Reel/Frame 6579/0466;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreements, as applicable.

2. Release. The Collateral Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the Trademark Collateral, including the trademark registrations and applications set forth on Schedule I attached hereto, arising under the Security Agreement and the Trademark Security Agreements. If and to the extent that the Collateral Agent has acquired any right, title or interest in and to the Trademark Collateral under the Trademark Security Agreements, the Collateral Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantor.

3. Termination. The Collateral Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Agreements.

4. Further Assurances. The Collateral Agent agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance

(including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.
