**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of December 17, 2021, by **UBS AG, STAMFORD BRANCH**, a Switzerland Aktiengesellschaft (AG) (“Collateral Agent”) in favor of **NTHRIVE REVENUE SYSTEMS, LLC**, a Delaware limited liability company with an address at 200 North Point Center East, Suite 400, Alpharetta, Georgia 30022, **EQUATION CONSULTING, LLC**, a Utah limited liability company with an address at 200 North Point Center East, Suite 400, Alpharetta, Georgia 30022, and **NTHRIVE, INC.**, a Delaware corporation with an address at 200 North Point Center East, Suite 400, Alpharetta, Georgia 30022 (each, a “Grantor” and collectively, the “Grantors”).

W I T N E S S E T H:

WHEREAS, with reference to the Second Lien Security Agreement, dated as of January 28, 2021 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), the Grantors entered into a Second Lien Intellectual Property Security Agreement, dated as of January 28, 2021 (the “IP Security Agreement”), with the Collateral Agent, notice of which was recorded on April 2, 2021 at the United States Patent and Trademark Office at Reel 7243, Frame 0501.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.

WHEREAS, Grantors granted the Collateral Agent, under the terms of the Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to all of each such Grantor’s right, title and interest in, to and under its Intellectual Property Collateral consisting of Trademarks, including without limitation its Trademarks listed in Schedule A.

WHEREAS, the Collateral Agent has agreed to terminate and release its Security Interest in all Intellectual Property Collateral consisting of Trademarks, including the Trademarks listed in Schedule A as herein provided.

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, and intending to be legally bound, the Collateral Agent hereby releases, terminates and discharges any and all of its interest in the Intellectual Property Collateral consisting of Trademarks, including the Trademarks listed in Schedule A hereto, and assigns, transfers and conveys to Grantors the Security Interest.

This agreement shall be governed by, and construed in accordance with, the law of the State of New York.
